Union Budget 2020 saw the Honourable Finance Minister Mrs. Nirmala Sitharaman announced a new tax regime with more tax slabs and lower tax rates. This was long demanded by most taxpayers, but it came with the catch of removal of all the deductions and exemptions available. However the New Tax Regime is optional. To put it simply, the assessee can choose between the New Tax Regime and the Old Tax Regime depending on what is best suitable from a tax planning point of view. A salaried taxpayer can opt-in and opt-out every year. That means you can choose the new tax regime in one year and choose the regular tax regime in another year. Against this backdrop, the present webinar is organized to have a bird's eye view on the personal tax planning aspect from the perspective of existing and new tax regime.
