## ANTI RAGGING POLICY :

### **HATE RAGGING: MAKE FRIENDSHIP**

#### **PREAMBLE:**

- In view of the direction of the Honourable Supreme Court dated 8/05/2009 and in consideration of the determination of the Central Government and the University Grants Commission we are determined to prohibit, prevent and eliminate the scourge of ragging within our college campus.

#### **OBJECTIVE:**

- Our objective is to eliminate ragging in all its forms from our college campus by prohibiting it under UGC Regulations, preventing its occurrence and punishing those who indulge in ragging as provided by the appropriate laws in force.

#### **FORMS OF RAGGING:**

##### **VERBAL ABUSE:**

- Any conduct by any student or students either by spoken or written words or by an act that has the effect of teasing, treating or handling with rudeness on a fresher or any other students. Any conduct by emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other students will fall under this category.

##### **PSYCHOLOGICAL ABUSE:**

- Indulging in rowdy or undisciplined activities by any student or students which cause or is likely to cause annoyance, hardship, psychological harm or to raise fear or apprehension thereof in any fresher or any other students. Forcing any student to do any act which may cause or generate sense of shame, embarrassment so as to adversely affect the psyche of such fresher or any other student

##### **PHYSICAL ABUSE:**

- Any kind of physical abuse causing bodily harm or any sort of danger to health or person.

## SEXUAL ABUSE:

- All kinds of sexual abuse including homosexual assaults, stripping, forcing into obscene and lewd acts.

## FINANCIAL ABUSE:

- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.

## MEASURES:

- In case of occurrence of any of the above mentioned incidence of ragging students are free to make written complaint or talk to the concerned persons of the college. Students' right to privacy will be preserved in such case. Appropriate measures as per law will be taken by the college to redress the complaint.

## **REPORT OF THE FIRST VISIT OF COLLEGE HOSTEL BY ANTI RAGGING CELL:**

On 30th May, 2019 one post graduate student from 4th semester, Geography, made a verbal complaint to the Principal about one incidence of harassment that happened to her at the college hostel. On receiving that complaint the Principal asked the anti ragging cell of the college to investigate the matter. On the very next day (31/05/2019) we (myself Sudeshna Mitra and Prof. Soma Chandra) as a representatives of the Cell made a surprise visit to the hostel. We talked to a few residents of the college hostel and found that two parties were involved in the matter. We talked to both the parties and asked them to formally register the complaint to the Principal in writing. We reported to the Principal about our prima facie impression of the matter. The matter will be aptly taken care of after receiving the formal complaint.
